Please take the time to read the Terms And Conditions laid out below before sending your booking.

- Booking** - Once CARPEDIEM ANGLING Ltd receive your completed booking and deposit, your holiday will be reserved for you and your party. Your booking is taken to be confirmed and accepted in respect to all persons travelling when we forward our invoice to the person signing the booking.
- Deposit** - A non-refundable deposit of £100 per angler must accompany your booking.
- Balance of Payment** - is required no later than 8 weeks prior to your booked arrival date. If a booking is placed within 10 weeks of your arrival date, the total cost of the holiday must be included with the booking. If full payment is not received 8 weeks prior to your booked date, CARPEDIEM ANGLING Ltd reserve the right to cancel your booking: payment may not be refunded and a cancellation fee incurred.
- Cancellation** - If, however you cancel your confirmed booking, it will only be accepted in writing, signed by the Group Organiser and the following fees will be incurred: -
 - Cancellation more than 8 weeks prior to your travel date - cancellation fee = deposit only
 - Cancellation 4 to 8 weeks prior to your travel date - cancellation fee = 50% of the total cost
 - Cancellation less than 4 weeks prior to your travel date - cancellation fee = total cost of the holiday
- Booking Changes** - If any changes to a confirmed booking are required, we will try and be flexible wherever possible.
- Passports** - All guests should ensure that they hold the appropriate passport and travel documents at the time of travel. It is strongly advised that you have a current EHC and adequate travel insurance before travelling.
- Travel Arrangements** - All travel arrangements / requirements are your responsibility and CARPEDIEM ANGLING Ltd accepts no responsibility for delays or cancellations to crossings via any method or, if there are any irregularities with your documents.
- Children** - We do not consider the fishery suitable for children under 14 years of age. All children between the ages of 14 and 16 years must be accompanied by an adult.
- Pets** - Pets are not allowed.
- Fishery Rules and Regulations** - All persons holidaying at Etang le Fays (anglers and guests) must agree to abide by the rules laid down by the Management Staff.
- Jurisdiction** - Signature on the booking form constitutes acceptance of a contract on these terms subject to English Law and the exclusive jurisdiction of the English Courts.
